The Board can set varying levels of initiation fees and/or dues for each of these classifications at any time. Once the member turns 31 years of age, they would be responsible for the dues of the junior classification for aged 31 to 39. Once the member turns 40 years of age, they will be considered a regular member and be responsible for the dues of a regular member. A junior members shall have full Club privileges as does a regular member, including voting privileges.*

In the event no designee is currently assigned to the membership, the corporation or company must continue to pay appropriate monthly dues and fees until such time as the corporation or company appoints a new designee.*
